Withdrawal of Restrictions from Scheduled District No. III.

1. From and after the twenty-first day of August, nineteen hundred and ten, the provisions of the Yorkshire (Foot-and-Mouth Disease) Orders of 1910 (No. 3) and (No. 4), dated the second and eleventh days of August, nineteen hundred and ten, respectively, shall cease to operate with respect to the Scheduled District No. III described in the Third Schedule to the secondly above-mentioned Order.
