MOTOR CAR ACT, 1903.

County of West Sussex.

Whereas by sub-section 1 of section 9 of the Motor Car Act, 1903, it is enacted that within

any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour :

Notice is hereby given that the County Council of West Sussex have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising the following portions of Lower Shoreham-road within the Urban District of Southwick, that is to say :—

So much as extends from the western boundary of the urban district to a point opposite the Coastguard Station ; and

So much as extends from a point in Fishergate-terrace 100 yards west of West-road to the eastern boundary of the urban district.

Notice is hereby further given that objections to the making of any such regulation may be sent in writing to the Local Government Board, at their offices at Whitehall, London, on or before the fifteenth day of September, 1910.

A copy of any such objection should be sent at the same time by the objector to the County Council addressed to the Clerk to the County Council of West Sussex, County Hall, Lewes.
