## TELEPHONE REGULATIONS.

## MOTOR CAR ACT, 1903.

## County of West Sussex.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas the County Council of West Sussex have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising so much of the road from Steyning to Petworth, passing through the village of Storrington, as extends from a point situate 135 yards east of Chantry Cross Roads to the gate leading to Spear Bridge Farm:

And whereas notice of the said application and of the time and manner in which objections should be made to any such regulation appeared in the London Gazette of the 19th day of August, 1910, and in the "West Sussex Gazette" of the 25th day of August, 1910:

And whereas certain objections to the making of any regulation in pursuance of the said provisions have been received by the Local Government Board, and it is expedient that further inquiry should be made in the matter of the said application:

Notice is hereby given that R. C. Maxwell, Esquire, Barrister-at-Law, one of the Inspectors of the Local Government Board, will attend at the Village Hall, Storrington, on Saturday, the twenty-ninth day of October, 1910, at half-past

PUBLIC HEALTH ACTS AMENDMENT ACT,  
1907.

## BOROUGH OF BEDFORD.

BY an Order of the Local Government Board made on the 24th day of September, 1910, it was declared and directed that certain parts and sections of the Public Health Acts Amendment Act, 1907, that is to say:—

Sections 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 29, 30, 31, 32 and 33 comprised in Part II;

Sections 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 49 and 51 comprised in Part III;

Sections 52, 53, 54, 55, 56, 57, 58, 59, 60, 62, 63, 64, 65 and 66 comprised in Part IV;

Part V;

Part VI; and

Part X;

(subject nevertheless as to Part II, sections 25 and 27; Part III, sections 35 and 38; Part IV, section 59; and Part V, section 75, respectively, of the 1907 Act to the conditions and adaptations set out and contained in the second column of the schedule to the said Order) should be in force in the district of the borough of Bedford as from the 12th day of November, 1910.
