"The District Chapelry of Saint George, Waterlooville, comprising:—

"1. All that extra parochial place called Waterloo, in the county of Southampton and in the diocese of Winchester.

"2. Also all that portion of the parish of Catherington, in the said county and diocese, which is bounded upon the south by the said extra parochial place called Waterloo, upon the east by the parish of Bedhampton, in the said county and diocese, and upon the remaining sides, that is to say, upon the north-east and upon the north-west, by an imaginary line commencing at the point where the boundary which divides the said parish of Bedhampton from the said parish of Catherington crosses the middle of Park-lane, and extending thence north-westward along the middle of Park-lane for a distance of forty chains or thereabouts to its junction with the road leading from Portsmouth to Petersfield, and extending thence westward across the last mentioned road for a distance of fourteen yards or thereabouts to the south-eastern end of the fence which divides the close numbered 666 upon the Ordnance Map of the civil parish of Catherington published in the year one thousand nine hundred and nine upon the scale of twenty-five inches to a mile and also upon the map or plan which is annexed to this representation, from the close numbered 693A upon the said maps, and extending thence first generally north-westward and then in various directions along the fences which divide the said close numbered 666, and the closes numbered 665A, 664, 661, 505, 506, 621, 624, and 626 upon the said maps from the said close numbered 693A, and the closes numbered 693, 659, 660, 623, 646, and 645 upon the said maps for a distance of seventy-six chains or thereabouts to the point where the fence which divides the said close numbered 626 from the said close numbered 645 crosses the middle of the stream which flows past the north-western side of the house and premises known as Hart Plain House, and extending thence generally south-westward along the middle of the said stream for a distance of thirty-six chains or thereabouts to the point where the boundaries of the said parish of Catherington, of the new parish of All Saints, Denmead, in the said county and diocese, and of the said extra parochial place called Waterloo all meet."

And whereas the said representation has been approved by His Majesty in Council:

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the twenty-eighth day of July, in the year one thousand nine hundred and ten, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint Aidan, Basford, situate in the parish of Basford, in the county of Nottingham and in the diocese of Southwell.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Aidan, Basford, situate as aforesaid.

"Now, therefore, with the consent of the Right Reverend Edwyn, Bishop of Southwell (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Basford, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Aidan, Basford, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Aidan, Basford.'
