diocese, apon part of the east by the last-named new parish, and upon the remaining sides, that is to say, upon the remaining part of the east, upon the south and upon the south-west, by an imaginary line commencing at the point where the boundary which divides the said new parish of Saint Jude, South Shields, from the said parish of Saint Mary, Jarrow Docks, diverges from following the middle of South Eldon-street, and extending thence southward along the middle of South Eldon-street for a distance of four chains and a half or thereabouts to its junction with Barnes-road, and extending thence westward along the middle of Barnes-road and of the roadway in continuation thereof (thereby passing under the Newcastle and South Shields line of the North Eastern Railway) for a distance mall of sixteen chains, or thereabouts, to the junction of the said roadway with the road leading from Tyne Dock to Corstorphine Town, and extending thence north-westward in a straight line for a distance of fourteen chains or thereabouts to a point in the middle of the dock gates at the main entrance to the Tyne Dock, and extending thence uorthward along the middle of the main entrance to the dock and in a line parallel with the wall on the western side of the said entrance for a distance of six chains or thereabouts to a point opposite to the northern end of the said wall, and extending thence north-westward in a straight line for a distance of fourteen chains or thereabouts to the point where the boundary which divides the said parish of Saint Mary. Jarrow Docks, from the said new parish of the Holy Trinity, South Shields, reaches the middle of the River Tyne.

"2. And also all that portion of the said new parish of Saint Jude, South Shields, which is bounded upon the south by the said parish of Saint Mary, Jarrow Docks, upon the north-west and upon the north by the said new parish of the Holy Trinity, South Shields, and upon the remaining side, that is to say, upon the east, by an imaginary line commencing upon the boundary which divides the said new parish of the Holy Trinity, South Shields, from the said new parish of Saint Jude, South Shields, at the junction of Havelock-street with Eldon-street, and extending thence southward along the middle of Eldonstreet for a distance of thirteen chains or thereabouts to its junction with Corbridge-street upon the boundary which divides the said new parish of Saint Jude, South Shields, from the said parish of Saint Mary, Jarrow Docks."

And whereas drafts of the said scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such scheme.

And whereas the said scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Durham.

W for England have in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a representation, bearing date the twentyeighth day of July, in the year one thousand nine hundred and ten, in the words and figures following, that is to say:--

ing, that is to say :---"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of the Good Shepherd, West Bromwich, situate within the new parish (sometime district chapelry) of Saint John the Evangelist, West Bromwich, in the county of Stafford, and in the diocese of Lichfield.

"Whereas at certain extremities of the said new parish of Saint John the Evangelist, West Bromwich, and of the new parish (sometime particular district) of the Holy Trinity, West Bromwich, in the county and diocese aforesaid, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such new parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of Saint John the Evangelist, West Bromwich, and of the said new parish of the Holy Trinity, West Bromwich, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of the Good Shepherd, West Bromwich, situate as aforesaid. "Now therefore, with the consent of the Honourable and Right Reverend Augustus,

Bishop of Lichfield, as such Bishop, and also as the Patron (in right of his See) of the vicarage of the said new parish of Saint John the Evangelist, West Bromwich, and with the consents of the Right Reverend John Taylor Smith, some time Bishop of Sierra Leone and now Chaplain-General to Your Majesty's Forces, of the Reverend Charles James Procter, of the Vicarage, Islington, in the county of Middlesex, Clerk in Holy Orders, of Robert Barclay, of High Leigh, Hoddesdon, in the county of Hertford, Esquire, and of John Henry Buxton, of Easneye,' Ware, in the said county of Hertford, Esquire, as the Patrons of the vicarage of the said new parish of the Holy Trinity, West Bromwich (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Saint John the Evangelist, West Bromwich, and of the said new parish of the Holy Trinity, West Brom-
