wich, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of the Good Shepherd, West Bromwich, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of the Good Shepherd, West Bromwich.'

"We, therefore, humbly praythat Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The consolidated chapelry of the Good Shepherd, West Bromwich, comprising:—

"I. All that portion of the new parish (sometime district chapelry) of Saint John the Evangelist, West Bromwich, in the county of Stafford and in the diocese of Lichfield, which is bounded upon the south by the new parish of Saint Paul, West Smethwick, in the said county of Stafford and in the diocese of Birmingham, upon the east by the new parish (sometime particular district) of the Holy Trinity, West Bromwich, upon the north-east by the district parish of Christ Church, West Bromwich, both in the said county of Stafford and in the said diocese of Lichfield, and upon the remaining side, that is to say, upon the west, by an imaginary line commencing upon the boundary which divides the said district parish of Christ Church, West Bromwich, from the said new parish of Saint John the Evangelist, West Bromwich, at a point in the middle of the Birmingham, Wolverhamp-ton and Dudley line of the Great Western Railway opposite to the middle of Pleasant-street, and extending thence southward to and along the middle of Pleasant-street for a distance of twenty-one chains or thereabouts to its junction with Sams-lane, and extending thence north-westward along the middle of Sams-lane for a distance of five chains and a half or thereabouts to its junction with the roadway leading along the backs of the houses on the eastern side of Morris-street to the Spon-lane Colliery, and extending thence southward along the middle of the said roadway for a distance of eleven chains and a half or thereabouts to the point where such roadway turns south-eastward along the northern side of Spon-lane Colliery, and continuing thence southward in precisely the same direction and in a straight line (thereby crossing the said colliery, passing to the west of the Spon-lane Iron Foundry and crossing the Spon-lane Locks of the Birmingham Canal Navigation) for a distance of twenty-two chains or thereabouts to the boundary which divides the said new parish of Saint John the Evangelist, West Bromwich, from the said new parish of Saint Paul, West Smethwick.

"II. And also all that contiguous portion of the said new parish of the Holy Trinity, West Bromwich, which is bounded upon the south by the said new parish of Saint Paul, West Smethwick, upon the west by the above described portion of the said new parish of Saint John the Evangelist, West Bromwich, and upon the remaining sides, that is to say, upon the northeast and upon the east, by an imaginary line commencing at the point in the middle of the bridge which carries Spon-lane across the Birmingham, Wolverhampton and Dudley line of the Great Western Railway, where the boundaries of the said new parish of Saint John the

Evangelist, West Bromwich, the said district parish of Christ Church, West Bromwich, and the said new parish of the Holy Trinity, West Bromwich, all meet, and extending thence southeastward along the middle of the said line of railway for a distance of six chains and a quarter or thereabouts to a point opposite to the northern end of the wall or fence forming the eastern boundary of the houses and premises known as Railway-terrace, and extending thence southwestward in a straight line (thereby passing to the east of Railway-terrace) for a distance of four chains and a half or thereabouts to a point in the middle of the wall or fence at the northern end of the passage running between the houses and premises known as numbers 14 and 16, Boulton-road, and extending thence southward along the middle of the said passage to its junction with Boulton - road, and extending thence eastward along the middle of Boultonroad for a distance of two chains and a quarter or thereabouts to its junction with Arthurstreet, and extending thence southward along the middle of Arthur-street for a distance of fourteen chains and a half or thereabouts to its junction with Parliament-street, and extending thence eastward along the middle of Parliamentstreet for a distance of three chains and a quarter or thereabouts to its junction with Lower Trinity-street, and extending thence southward along the middle of Lower Trinitystreet for a distance of nine chains and a half or thereabouts to its junction with Union-street, and extending thence westward along the middle of Union-street for a distance of two chains and a half or thereabouts to its junction with Hallstreet South, and extending thence southward along the middle of Hall-street South for a distance of six chains or thereabouts to its junction with Houghton street, and continuing thence southward in precisely the same direction and in a straight line for a distance of three chains or thereabouts to a point in the middle of the Birmingham Canal (Wolverhampton Level) upon the boundary which divides the said new parish of the Holy Trinity, West Bromwich, from the said new parish of Saint Paul, West Smethwick."

And whereas the said representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Lichfield.
