In pursuance of an Act for better preserving the Navigation of the River Mersey (5 and 6 Victoria, cap. 110), we, Joseph Crosfield and Sons Limited, Bank Quay, Warrington, Soap and Chemical Manufacturers, hereby give you notice that we propose to construct at Walton, near Warrington, in accordance with plans and sections deposited at the Office of the Mersey Conservancy, two timber Dolphins, together with a floating steel Pontoon to be secured between the Dolphins.

The Dolphins will be constructed on lines which will correspond generally with the lines of the tidal flow and ebb at the place at which they are to be erected: the projection of the Dolphins into the tideway will be about 40 feet (measured from the line of high water on the Cheshire side of the River Mersey), and the object of the Dolphins and of the floating Pontoon is to provide a landing stage for a steam ferry for the accommodation of work-men employed at the cement works in Walton.

The Dolphins will exclude about 30 cubic yards of tidal water on a tide of the height of 21 feet, as measured from the sill of the Old Dock Gates in Liverpool.

The work will be commenced immediately upon the sanction of the Mersey Conservancy having been obtained thereto.
