"And whereas the transfer of the patronage of the said benefice of Saint Clether, which is hereinbefore mentioned and hereinafter recommended and proposed, will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred

as aforesaid arises or exists, that is to say, in the parish of Saint Clether. "Now, therefore, with the consent of the said John Carpenter-Garnier (in testimony whereof he has signed and sealed this scheme) and with the consent of the said Charles William, Bishop of Truro (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Saint Clether, now vested in him, the said John -Carpenter-Garnier as aforesaid, shall be transferred to the said Charles William, Bishop of Truro, and his successors in the same bishoprick, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Charles William, Bishop of Truro, and by his successors in the same bishoprick for

ever. "And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.'

And whereas the said scheme has been

approved by His Majesty in Council: Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Truro.

WHEREAS the Ecclesiastical Commis-W sioners for England have, in pursu-ance of the Act of the sixteenth and seven-teenth years of Her late Majesty Queen Vic-toria, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of Her said late Majesty, chapter one hundred and twénty-four, duly prepared and laid before His Majesty in Council a scheme bearing date the third day of November, in the year one thousand nine hundred and ten, in the words and figures following, that is to say :-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the six-teenth and seventeenth years of Her late Majesty Queen Victoria, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of Her said late Majesty, chapter one hundred and twenty-four, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting an exchange of the patronage of the benefice (being a vicarage) of All Saints, Sydenham, situate in the county of Kent and in the diocese of Southwark, for the patronage of the benefice (being a vicarage) of Saint Michael and All Angels, Bell Green, Lower Sydenham, situate in the said county of Kent and in the said diocese of Southwark.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of All Saints, Sydenham, is vested in the Bishop of Southwark in right of his See. "And whereas the advowson or perpetual

right of patronage of and presentation to the said benefice of Saint Michael and All Angels, Bell Green, Lower Sydenham, is vested in the vicar or incumbent of the vicarage of Saint Bartholomew, Sydenham, in the said county of Kent and in the said diocese of Southwark; as such vicar or incumbent.

"And whereas the Right Reverend Edward Stuart, now Bishop of Southwark, and the Reverend William Perowne Holmes, now vicar or incumbent of the said vicarage of Saint Bartholomew, Sydenham, have respectively signified to us their desire that the patronage of the said two benefices of All Saints, Sydenham, and Saint Michael and All Angels, Bell Green, Lower Sydenham, may be re-arranged by way of exchange in the manner which is hereinafter recommended and proposed.

"And whereas we have made due enquiry and calculation as to the circumstances and relative value of the said two benefices and of the patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present value of the said two benefices are as set forth in the schedule hereunto annexed.

"Now therefore with the consent of the said Edward Stuart, Bishop of Southwark, acting as such Bishop (in testimony of which consent he has affixed his signature and episcopal seal to this scheme) and with the consent of the said William Perowne Holmes, vicar or incumbent of the said vicarage of Saint Bartholomew, Sydenham, acting as such vicar or incumbent (in testimony whereof he has signed and sealed this scheme) we, the said Ecclesiasti-cal Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and pre-sentation to the said benefice of All Saints, Sydenham, and the church thereof shall be assigned and transferred from the said Edward Stuart, Bishop of Southwark, and from his successors in the same bishoprick, and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said William Perowne Holmes,
