he is the same Petitioner, or his representative (and if representative in what capacity), and that the Petition was allowed in 1901-2, in order that there may be a record.

- 5. No Claim excluded by the Court in 1901-2 as inappropriate to the Coronation by reason of the Royal Proclamation, and inappropriate for the same reason to the forthcoming Coronation, will be placed on the List.
- 6. Any Claim now made, which was referred by the Court in 1901-2 to the Executive Committee for the purposes of arrangements for the Coronation, shall be referred to the same Committee.
- 7. Petitioners to be requested to present their Claims on or before the 14th January, 1911.

His Lordship further announced that the Court stood adjourned to some day in the month of January next, of which notice would be given in the London Gazette.

His Majesty the KING has been pleased to award the Edward Medal of the Second Class to Mr. John Evans, an Engine Driver in the employ of the North Eastern Railway Company, under the following circumstances:

On the 17th October Evans was driving a locomotive with a set of empty trucks on the North Eastern Railway near Amble, in Northumberland, when he saw a little child in the four-foot way in front of the train, which was moving at a good pace. He shut off the steam, and, jumping off his engine, managed to reach the child and fall back with her in his arms clear of the rails before the engine reached the spot. His prompt action in the face of danger undoubtedly saved the child's life.

WILD BIRD (ENGLAND).

The Wild Birds Protection (Administrative County of Cambridge) Order, 1910.

Dated 21st December, 1910.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the Administrative County of Cambridge, I hereby make the following Order:-

I. This Order may be cited as "The Wild Birds Protection (Administrative County of Cambridge) Order, 1910."

BIRDS.

Addition to the Schedule of the Act of 1880. II. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of Cambridge to the Great Bustard in the same manner as if that species of bird were included in the Schedule to the Act.

Certain Birds protected during the whole of the Year.

III. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, does not extend, the killing or taking of the following species of Wild Birds is prohibited throughout the Administrative County of Cambridge:

Common Bittern, Great Bustard, Goldfinch, Kingfisher, Owl (all species).

Eggs.

All Eggs protected within a certain Area.

IV. The taking or destroying of Wild Birds' Eggs is prohibited within that part of the Administrative County of Cambridge known as Wicken Sedge Fen for a period of three years from the date of this Order.

Repeal of former Order.

V. The Order of the 7th December, 1907, is hereby repealed.

The Wild Birds Protection (Administrative County of Stafford) Order, 1910.

Dated 21st December, 1910.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the Administrative County of Stafford, I hereby make the following Order:

Title.

I. This Order may be cited as "The Wild Birds Protection (Administrative County of Stafford) Order, 1910."

BIRDS.

Close Time Extended.

II. The time during which the killing or taking of Wild Birds is prohibited by the Act of 1880 shall be extended throughout the Administrative County of Stafford, so far as concerns all Wild Birds except Woodcock, so as to be between the 1st day of March and the 12th day of August in any year.

The close time for Woodcock is hereby extended so as to be between the 1st day of February and the 12th day of August in any

Additions to the Schedule of the Act of 1880. III. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of Stafford to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:-

Hedge Accentor (Hedge Sparrow), Bunting (all species), Chiffchaff, Tree Creeper, Dipper or Water Ouzel, Golden Eagle, Sea Eagle, Peregrine Falcon, Pied Flycatcher, Spotted Flycatcher, Hobby, Kite, House Martin, Sand Martin, Merlin, Nuthatch, Osprey, Ring Ouzel, Redstart, Robin, Great Grey Shrike, Lesser Grey Shrike, Red-backed Shrike, Woodchat Shrike, Stonechat, Swallow, Swift, Wagtail (all species), Aquatic Warbler, Blackcap Warbler, Dartford Warbler, Garden Warbler, Grasshopper Warbler, Marsh Warbler, Reed Warbler, Sedge Warbler, Willow Warbler, Wood Warbler, Wheatear, Whinchat, White-throat, Lesser Whitethroat, Common Wren, Fire-crested Wren, Golden-crested Wren, Wryneck (Cuckoo's Mate or Snakebird).

The House Sparrow deprived of protection.

IV. The Administrative County of Stafford is hereby exempted from the operation of the Wild Birds Protection Act, 1880, so far as the House Sparrow is concerned.
