WHEREAS the Overseers of the Poor of the Township of Worsley, pursuant to a Resolution of the Vestry at a Meeting on Thursday, the 24th day of November, 1910, have applied to Us, the Local Government Board, for an Order putting in force in the township so much of the Vestries Act, 1850, as relates to the provision of accommodation for holding Vestry and other Parish Meetings:
