Vestry or other Meetings shall forthwith be applied to and be put in force within the said Township of Worsley.

ARTICLE II.—A copy of this Order shall be published in the London Gazette by the Overseers of the Poor of the said township.

## TOWNSHIP OF MANCHESTER.

To the Guardians of the Poor of the Township of Manchester;—

And to all others whom it may concern.

WHEREAS by a General Order dated the 14th day of December, 1852, addressed to the Guardians of the Poor of certain Poor Law Unions, including the Township of Manchester, the Poor Law Board prescribed Regulations with regard to the administration of out-door relief to poor persons in the said township;

And whereas by an Order dated the 26th day of June, 1909 (hereinafter referred to as "the Order of 1909"), We, the Local Government Board, made temporary provision with regard to the administration of relief to certain classes of poor persons in the said township; and by virtue of further Orders dated respectively the 19th day of March, 1910, and the 31st day of May, 1910 (hereinafter referred to as "the Orders of 1910"), the provisions of the Order of 1909 were continued in operation until the 25th day of March, 1911;

And whereas it is expedient that such further provision as is hereinafter set forth should be made in relation to the subject-matter of the Order of 1909:

NOW THEREFORE in pursuance of the power given to Us by the statutes in that behalf, We do hereby Order that notwithstanding anything in the Order of 1909 or in the Orders of 1910, the provisions of the Order of 1909 shall operate and shall have effect until the Thirtieth day of June, One thousand nine hundred and eleven.
