the limits of the said proposed separate district any consecrated church or chapel in use for the purposes of divine worship. ""And whereas certain glebe lands, tithe

And whereas certain glebe lands, tithe rentcharges, rents, hereditaments, investments, funds, and other property sometime belonging to the parish of Saint Mary in Stockport, being one of the two distinct and separate parishes into which the said parish of Stockport has been divided, have become vested in us under the provisions of and for the purposes of the lastly hereinbefore mentioned Act.

"And whereas the district hereinafter recommended to be constituted will be permanently endowed under the provisions contained in the sixth section of the said lastly mentioned Act with an annual sum of one hundred and fifty pounds so soon as a minister shall have been duly licensed in accordance with the provisions of the first herein mentioned Act, and such endowment will after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme be secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our common seal in accordance with the provisions contained in the ninth section of the said Saint Mary Stockport Rectory Act, 1910.

"Now therefore with the consent of the Right Reverend Francis John, Bishop of Chester, (in testimony whereof he has signed and sealed this scheme) we, the said Ecclesiastical Commissioners, humbly recommend and propose that all that part of the said new parish of Saint Matthew, Stockport, which is described in the schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed, shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme as aforesaid become and be constituted a separate district for spiritual purposes and that the same shall be named ' The District of Saint Mark, Stockport.'

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The district of Saint Mark, Stockport, being : —All that part of the new parish (some-time district) of Saint Matthew, Stockport, in the county of Chester and in the diocese of Chester, which is bounded upon all sides as follows, that is to say, upon the east by the parish of Saint Thomas, Stockport, upon the south-east and upon the south by the parish of Cheadle, upon the south-west, upon the north-west, and upon part of the north by the consolidated chapelry of Saint Augustine, Brinksway, all in the said county and diocese, and upon the remaining part of the north by an imaginary line commencing upon the boundary which divides the said consolidated chapelry of Saint Augustine, Brinksway, from the said new parish of Saint Matthew, Stockport, at the junction of Edgeley Road with Northgate Street, and extending thence north-eastward along the middle of Edgeley Road and Castle Street for a distance of forty chains

or thereabouts to the boundary which divides the said new parish of Saint Matthew, Stockport, from the said parish of Saint Thomas, Stockport."

And whereas drafts of the said scheme have, in accordance with the provisions of the firstly hereinbefore mentioned Act, been transmitted to the patron and to the incumbent of the new parish out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patron and incumbent have respectively signified their assent to such scheme.

And whereas the said scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chester.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her late Majesty Queen Victoria, chapter thirty-seven, of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, and of the Act of the twenty-ninth and thirtieth years of Her said late Majesty, chapter eighty-six, duly prepared and laid before His Majesty in Council a scheme bearing date the sixth day of April, in the year one thousand nine hundred and eleven, in the words and figures following, that is to say :—

is to say :--"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of Her late Majesty Queen Victoria, chapter thirty-seven, of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, and of the Act of the twenty-ninth and thirtieth years of Her said late Majesty, chapter eighty-six, have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken partly out of the chapelry of Milnrow and partly out of the new parish (sometime district) of Newbold, both within the original limits of the parish of Rochdale, in the county of Lancaster and in the diocese of Manchester.

the diocese of Manchester. "Whereas we are satisfied that the said chapelry of Milnrow and the said new parish of Newbold are cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said chapelry of Milnrow, and of the said new parish of New-
