Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Beddington and of the said parish of Coulsdon, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Mark, Woodcote, Purley, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Mark, Woodcote, Purley.'

Chapelry of Saint Mark, Woodcote, Purley.' "We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal Consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mark, Woodcote, Purley, comprising: —All those con-tiguous portions of the parish of Beddington and of the parish of Coulsdon, both in the county of Surrey and in the diocese of Southwark, which, taken together, are bounded upon the west partly by the parish of Carshalton, and partly by the new parish of Wallington, upon the north by the consolidated chapelry of Saint Michael and All Angels, South Beddington, all in the said county and diocese, upon part of the east by the parish of Croydon, in the said county of Surrey and in the diocese of Canterbury, and by the new parish of Christ Church, Purley, in the said county of Surrey and in the said diocese of Southwark, and upon the remaining sides, that is to say, upon the re-maining part of the east, upon the south-east and upon the south-west, by an imaginary line commencing upon the boundary which divides the said new parish of Christ Church, Purley, from the said parish of Beddington at the point where such boundary turns north-eastward along the middle of Brighton Road, and ex-tending south-eastward in a straight line in continuation of the south-western boundary of the said new parish of Christ Church, Purley (thereby crossing the boundary which divides the said parish of Beddington from the said parish of Coulsdon) for a distance of nine chains and a half of thereabouts to a point in the middle of the main line of the London, Brighton and South Coast Railway, and ex-tending thence south-westward along the middle of the said line of railway for a dis-tance of fourteen chains or thereabouts to the centre of the bridge which carries such line of railway across the Chipstead Valley branch line of the South-Eastern and Chatham Railway, and extending thence south-westward along the middle of such branch line of railway for a distance of nine chains and a half or thereabouts to a point opposite to the wall or fence forming the south-western boundary of the house and premises known as Firbank, and extending thence north-westward to and along the said wall or fence for a distance of four chains and a half or thereabouts to its north-western end upon the south-eastern side of Brighton Road, and extending thence first north-westward to and then south-westward along the middle of Brighton Road for a distance of forty-five chains or thereabouts to its junction with Smitham Downs Road, and extending thence first northward and then northwestward along the middle of Smitham Downs Road for a distance of forty-two chains or thereabouts to its junction with Smithambottom Lane, and extending thence north-westward along the middle of Smithambottom Lane for a distance of seven chains or thereabouts to its junction with the footpath leading to the Woodcote Park Golf Course, and extending thence south-westward along the middle of the said footpath for a distance of twenty chains or thereabouts to the point where such footpath is crossed by the boundary which divides the said parish of Beddington from the said parish of Carshalton."

And whereas the said representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Southwark.

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 19th day of April, 1911; in the words following, viz. :--

"Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council.

"And whereas by an Order in Council bearing date the 9th October, 1903, His late Majesty King Edward the Seventh was graciously pleased to institute the rank of Paymaster-in-Chief on the Active List, and to provide that officers retired from that rank should be granted retired pay on the scale applicable to Fleet Paymasters.

"And whereas we are of opinion that the scale of retired pay therein approved for Paymasters-in-Chief is inadequate, compared with the retired pay obtainable by other officers of corresponding relative rank. "We beg leave humbly to recommend that

We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction an addition of  $\pounds 10$  for each complete year's full pay service in the rank of Paymaster-in-Chief on the Active List being allowed in the assessment of the retired pay of officers of that rank retired on or after the 1st April, 1911, subject to the
