##### COUNTY OF HERTFORD (CHESHUNT) LIGHT RAILWAYS ORDER.

#### LIGHT RAILWAYS ACT, 1896.

##### TARPORLEY LIGHT RAILWAY (REVIVAL AND EXTENSION OF TIME) ORDER.

The Light Railway Commissioners have submitted to the Board of Trade for confirmation, under the above-mentioned Act, an Order made by them reviving the powers granted by the Tarporley Light Railway Order, 1906, for the compulsory purchase of lands and extending the periods limited by that Order for the same and for the completion of the railway and works thereby authorized.
