## WILD BIRD (ENGLAND).

The Wild Birds Protection (Administrative County of Cumberland) Order, 1911.

## Dated 20th June, 1911.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the Administrative County of Cumberland, I hereby make the following Order :---

#### Title.

I. This Order may be cited as "The Wild Birds Protection (Administrative County of Cumberland) Order, 1911."

#### BIRDS.

### Close Time extended.

II. The time during which the killing or taking of Wild Birds is prohibited within the Administrative County of Cumberland shall be extended so as to be between the first day of March and the first day of September in any year, except in the case of Plover (not including Lapwing, Peewit or Green Plover) and Wild Duck, the close time for which remains as fixed by the Wild Birds Protection Act, 1880, namely, between the first day of March and the first day of August in any year.

# Additions to the Schedule of the Act of 1880.

III. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of Cumberland to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:

Hedge Accentor (Hedge Sparrow), Reed Bunting, Buzzard, Chiffchaff, Corn Crake (or Land Rail), Tree Creeper, Crossbill, Dipper, Turtle Dove, Peregrine Falcon, Pied Fly-
