

MOTOR CAR ACT, 1903.

Regulations under Section 9 (1).

COUNTY OF SURREY.

Egham and Windlesham Urban Districts.

To the County Council of Surrey;—

And to all others whom it may concern.

WHEREAS by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in Regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas the County Council of Surrey having made application to Us to make Regulations in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising certain roads or parts of roads situate within the Urban Districts of Egham and Windlesham, in the County of Surrey, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon:

NOW THEREFORE, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:—

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the roads or parts of roads within the Urban Districts of Egham and Windlesham which are specified in the Schedule hereto.

ARTICLE II.—These Regulations shall come into operation on the fourteenth day of August, one thousand nine hundred and eleven.

SCHEDULE.

So much of the main road from Basingstoke to Staines, including High Street, Bagshot, as extends from its junction with Higg's Lane to a point 50 yards north of Station Approach.

The Square, Bagshot; and so much of the road leading from the Square towards Stone Hill as extends from the Square to a point in the road immediately east of the railway viaduct.

So much of the main road at Sunningdale as extends from the mile stone indicating 23 miles from Hyde Park Corner to a point 50 yards east of the junction of the road with Broomhall Lane.

COUNTY OF SURREY.

Byfleet and Chobham Parishes.

To the County Council of Surrey;—

And to all others whom it may concern.

WHEREAS by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in Regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the Local Authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas We have received and duly considered an application from the County Council of Surrey for the issue of a Regulation in pursuance of the said sub-section putting the above mentioned provisions of that sub-section in force within the limits comprising certain roads or parts of roads situate within the parishes of Byfleet and Chobham, in the county of Surrey:

NOW THEREFORE, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:—

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the roads or parts of roads within the said parishes which are specified in the Schedule hereto.

ARTICLE II.—These Regulations shall come into operation on the fourteenth day of August, one thousand nine hundred and eleven.

SCHEDULE.

IN THE PARISH OF BYFLEET.

So much of the road through the village of Byfleet as extends from a point opposite the western end of the fishpond on the west of the village to a point in the road 50 yards east of its junction with Green Lane.

IN THE PARISH OF CHOBHAM.

High Street, Chobham, from a point 95 yards south of Chobham Bridge to a point 50 yards south of Station Road;

So much of Station Road, Chobham, as extends from its junction with High Street to a point 50 yards east of the Village Hall and Institute; and

So much of Vicar's Lane as extends in a westerly direction for a distance of 225 yards from its junction with High Street.
