

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 16TH OCTOBER 1911.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

No cattle, sheep, goats or swine shall be moved along, over, or across the Drovers known as Church Drove, Oxlease Drove, and Stathe Drove, in Aller Moor, in the parish of Aller, in the administrative county of Somerset, except with permission in writing granted by an Inspector of the Board or of the Local Authority of the District.

WALTHAMSTOW URBAN DISTRICT.

NOTICE is hereby given, that by an Order dated the 9th day of October, 1911, the Local Government Board have confirmed an Order made on the 30th day of August, 1911, by the Urban District Council of Walthamstow, in pursuance of section 112 of the Public Health Act, 1875, as amended by section 51 of the Public Health Acts Amendment Act, 1907, declaring each of the trades of Blood drier, Leather dresser, Tanner, Fat melter or Fat extractor, Glue maker, Size maker, Gut scraper, Fish frier, Fish curer and Rag and bone dealer within the urban district of Walthamstow to be an offensive trade.

BYELAW relating to parks and places of public resort or recreation under the control of the Corporation.
