FACTORY AND WORKSHOP ACT, 1901.

The Secretary of State for the Home Department hereby gives notice, pursuant to section 3 (3) of the Rules Publication Act, 1893, that on the 25th October, 1911, he made an Order under section 116 of the Factory and Workshop Act, 1901, applying the provisions of that .section, with modifications, to non-textile factories and workshops or parts thereof in which the undermentioned classes of work, or any of .them, are carried on, and to out-workers employed in those classes of work and the .occupiers and contractors by whom they are .employed :---

(1) The making up, ornamenting, finishing and repairing of table linen, bed linen or other household linen (including in the term linen articles of cotton or cotton and linen mixtures), and any processes incidental thereto.

(2) The making of curtains and furniture hangings and any processes incidental thereto.

(3) Processes incidental to the making of lace.

This Order does not apply to any work to which the Bleaching and Dyeing Particulars 'Order, dated 22nd November, 1909, applies.
