**INSTRUMENT** substituting the new church of Saint John the Evangelist, situate within the new parish of Stainburn, in the county of York and in the diocese of Ripon, for the old church of Saint Mary the Virgin, situate within and hitherto being the parish church of the same new parish.

To all to whom these presents shall come the Ecclesiastical Commissioners for England send Greeting:

WHEREAS a new church has lately been built within the new parish of Stainburn, in the county of York and in the diocese of Ripon, and has been consecrated and dedicated to Saint John the Evangelist.

And whereas the Right Reverend William Boyd, Bishop of the said diocese of Ripon, as such Bishop, the Reverend Robert Lowe Bellamy, Clerk in Holy Orders, Rector or Incumbent of the rectory of the parish of Kirkby Overblow, in the said county and diocese, as the patron of the vicarage of the said new parish of Stainburn, and the Reverend Ernest Herbert Stott, Clerk in Holy Orders, as the Vicar or Incumbent of the said vicarage of Stainburn, have by an Instrument under their hands, bearing date on or about the fourteenth day of July, in the year one thousand nine hundred and eleven, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said new parish of Stainburn that the said new church of Saint John the Evangelist, situate within

such new parish, should be substituted for the old parish church (dedicated to Saint Mary the Virgin), of the same new parish.

Now, therefore, we, the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in any wise enabling us, in the same behalf, do by this instrument under our common seal, with the consents (testified as hereinafter mentioned) of the said William Boyd, Bishop of the said diocese of Ripon, and of the said Robert Lowe Bellamy, and of the said Ernest Herbert Stott, hereby declare that the said new church of Saint John the Evangelist, situate within the said new parish of Stainburn, and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church (dedicated to Saint Mary the Virgin as aforesaid) of the same new parish, and that such new church shall henceforth be the parish church of the said new parish of Stainburn, in lieu of the said old parish church, as fully in all respects as if the said new church of Saint John the Evangelist, so hereby substituted, had been originally the parish church of the same new parish; and we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned) do hereby transfer all the endowments, emoluments and rights of or belonging to the said old parish church (dedicated to Saint Mary the Virgin as aforesaid) of the said new parish of Stainburn, or of or belonging to the Vicar or Incumbent thereof, to the said new church of Saint John the Evangelist (now being by virtue of these presents the parish church of the said new parish of Stainburn), and to the Vicar or Incumbent thereof and his successors for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said William Boyd, Bishop of the said diocese of Ripon, has set his hand, and affixed his Episcopal Seal, and the said Robert Lowe Bellamy and the said Ernest Herbert Stott, have respectively set their hands and affixed their seals, this nineteenth day of October, in the year one thousand nine hundred and eleven.
