The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Telegram, dated the 6th November, from His Majesty's Representative at Madrid:—Owing to extension of plague in Morocco, notice inserted in (Government) Gazette all arrivals from infected ports must undergo deratization and disinfection. Ports possessing necessary installation are Barcelona, Bilbao, Cadiz, Cartagena, Coruna, Las Palmas, Mahon, Malaga, Palma, Santa Cruz, Santander, Seville, Valencia, and Vigo. All ships concerned should proceed direct to one of these.

- (2) The sanitary station at Surmené to be closed.
- (3) The medical visit in force on arrivals from ports situated between Confoudah and Mokka suppressed.
- (4) The measures in force on arrivals from Mohamarah suppressed.
