And whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 18th day of December, 1911, in the

words following, viz.:—
... "Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being, or having been, an officer, seaman, or Maxine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in

"And whereas prior to the 1st April, 1911, the Staff of Your Majesty's Naval Prisons at the Cape and Sydney were paid continuous extra pay at the rates payable in the Fleet for general work, in view of the high cost of living: "We beg leave humbly to recommend that

Your Majesty may be graciously pleased by Your Order in Council to sanction similar payments of extra pay to the Staff of the Detention Quarters at the Cape and Sydney from the 1st April, 1911, the date on which the Detention system came into force at those

places. , Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

Now, therefore, His Royal Highness Prince Arthur of Connaught, His Grace the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and the Lord President of the Council, being authorized thereto by His Majesty's said Commission, have taken the said Memorial into consideration, and do hereby, by and with the advice of His Privy Council, on His Majesty's behalf, approve of what is therein proposed, and do, on His Majesty's behalf, order that the Right Honourable the Lords Commissioners of the Admiralty do give the necessary directions herein accordingly.
