# Certain Eggs protected.

IV. The taking or destroying of the Eggs of the following species of Wild Birds and of those appearing in Clause II of this Order (being the birds named in the Schedule to the Wild Birds Protection Act, 1880, as amended by the Act of 1881) is prohibited throughout the Administrative County of Anglesey:

Eider Duck, Shoveller Duck, Mallard or Wild Duck, Goldfinch, Lark, Pochard or Dun-bird, Snipe, Teal, Widgeon, Woodcock, and (after April 1st in each year) Lapwing (Peewit

or Green Plover).

# Repeal of former Order.

#### WILD BIRD PROTECTION.

The Wild Birds Protection (Administrative County of the Parts of Kesteven, Lincolnshire) Order, 1912.

Dated 15th February, 1912.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the Administrative County of the Parts of Kesteven, Lincolnshire, I hereby make the following Order:-

# Title.

I. This Order may be cited as "The Wild Birds Protection (Administrative County of the Parts of Kesteven, Lincolnshire) Order, 1912."

#### BIRDS.

### Close time extended.

II. The time during which the killing or taking of Wild Birds is prohibited by the Act of 1880 shall be extended throughout the Administrative County of the Parts of Kesteven, Lincolnshire, so as to be between the last day of February and the 16th day of August in each year.

Additions to the Schedule of the Act of 1880.

III. The Wild Birds Protection Act, 1880, shall apply throughout the Administrative County of the Parts of Kesteven, Lincolnshire, to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:—Common Buzzard, Honey Buzzard, Hobby, Kestrel, House Martin, Sand Martin, Merlin, Swallow, Swift, Wryneck.

Certain Birds protected during the whole of the Year.

IV. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, as extended by Clause II. of this Order, does not apply, the killing or taking of the following species of Wild Birds is prohibited throughout the Administrative County of the Parts of Kesteven, Lincolnshire:—Goldfinch, Kingfisher, House Martin, Owl (all species), Swallow.

# Certain Eggs protected throughout the Administrative County.

V. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the Administrative County of the Parts of Kesteven, Lincolnshire:— Common Buzzard, Honey Buzzard, Wild Duck (all species), Goldfinch, Hobby, Kestrel, Kingfisher, House Martin, Sand Martin, Merlin, Nightingale, Nightjar, Owl (all species), Ruff or Reeve, Swallow, Swift, Teal, Woodpecker,  $\mathbf{W}$ ryneck.

Repeal of former Order.

VI. The Order of the 28th October, 1903, is hereby repealed.
