ORDER OF THE REGISTRAR-GENERAL
IN ENGLAND.

(Dated March 6th, 1912.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-districts:—

1. And whereas it is expedient, in the interest of public convenience, that the following changes should be made in the Sub-districts of Horsham Registration District, viz.:—

(1.) That the part of Horsham Rural Civil Parish now included in South Horsham Sub-district should be transferred to North Horsham Sub-district;

(2.) That West Horsham Sub-district should be abolished, and its constituent Civil Parishes added to South Horsham Sub-district;

(3.) That the Sub-districts of North Horsham and South Horsham as thus altered should be renamed "Horsham" and "Billingshurst" respectively;

2. Now, therefore, I, Bernard Mallet, C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above-mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on the first day of April, nineteen hundred and twelve.
