8. To extend to the Fish Dock Extension all or some of the provisions of the Harbours Docks and Piers Clauses Act, 1847, and so far as may be necessary all the powers now possessed by the Company in respect of their existing docks at Grimsby for the regulation and control of persons and vessels resorting to the Fish Dock Extension and of vehicles and appliances used thereat and the loading, unloading, storing, marketing and dispatch of fish and other commodities, and to authorize the making of new regulations for all or any of those purposes.

9. To authorize the Company to demand and recover for and in respect of the use of the Fish Dock Extension, and the landing and shipping thereat of fish, minerals, merchandise and other things all or any of the dues, rates and charges which they are authorized to demand and recover in respect of their existing

docks at Grimsby.

10. To authorize the Company for the purposes of the Fish Dock Extension to apply any moneys now in their possession or under their control or which they are or may be authorized to raise by any Act of Parliament already passed or to be passed in the present Session of Parliament, and to authorize the Company to raise further moneys by the creation and issue of a further amount of second debenture stock ranking pari passu with the existing and authorized Second Debenture Stock of the Company.

11. To confirm any contract or agreement which may have been, or which may hereafter be, entered into by or on behalf of the Company and any other party, for or in relation to any of the matters aforesaid, and to authorize the making and fulfilment of further contracts and agreements with reference

12. To vary or extinguish all existing rights and privileges which would interfere with the purposes of the Bill, and to confer other rights

and privileges.

13. The Bill will or may incorporate with itself with or without amendment and apply to the construction and use of the Fish Dock Extension, the provisions of the Harbours Docks and Piers Clauses Act, 1847, the Lands Clauses Consolidation Act, 1845, the Railways Clauses Consolidation Act, 1845, the Companies Clauses Consolidation Act, 1845, and the Companies Clauses Act, 1863; and it will or may so far as may be deemed expedient repeal, alter or enlarge the powers and provisions of the Act 12 and 13 Vict., cap. 81, and any other Act relating to the Company or their

undertaking.

And notice is hereby further given that as soon as leave shall have been given by Parliament to introduce the Bill, plans and sections of the Fish Dock Extension and works proposed to be authorized by the Bill, and plans of the lands proposed to be taken or interfered with compulsorily under the powers thereof, with a book of reference to those plans containing the names of the owners or reputed cwners, lessees, or reputed lessees, and occupiers of those lands, and a copy of this Notice will be deposited for public inspection with the Clerk of the Peace for the Parts of Lindsey of the County of Lincoln at his office at Lincoln, and with the Town Clerk of the Borough of Grimsby at his office at Grimsby, and with the Clerk to the Urban District Council of Cleethorpes-with-Thrunscoe at his office at Cleethorpes.
