MOTOR CAR ACT, 1903.

COUNTY OF EAST SUSSEX.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903, it is enacted that, within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas the County Council of East Sussex have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provision of that sub-section in force within the limits comprising the following roads or parts of roads within the parish of Lindfield, that is to say:—

So much of the main road from Hayward's Heath to Croydon passing through the village of Lindfield as extends from a point situate 50 yards west of its junction with Batchelors Lane (otherwise known as Denman's Lane) at the foot of Black Hill to a point situate 50 yards north of its junction with Spring Lane on Town Hill;

So much of the road from Lindfield to Lewes as extends from its junction with the main road aforesaid to a point 50 yards south-east of the County Council Schools, Lindfield Common; and

Batchelors Lane (otherwise known as Denman's Lane):

And whereas notice of the said application, and of the time and manner in which objections should be made to any such regulation appeared in the London Gazette of the 19th day of December, 1911, and in the Mid-Sussex Times of the 19th day of December, 1911:

And whereas certain objections to the making of any regulation in pursuance of the said provisions have been received by the Local Government Board, and it is expedient that further inquiry should be made in the matter of the said application:

DISTRICT AUDITORS ACT, 1879: Assignment of Duties and District (Supplemental).

HERTFORDSHIRE AUDIT DISTRICT.

To Herbert Lyon, District Auditor:—

To the Joint Committee (hereinafter termed "the Joint Committee") appointed by the Councils of the Rural Districts of Amphill and Newport Pagnell for the purpose of carrying out Joint Schemes of Water Supply and of Sewerage and Sewage disposal for the contributory places of Aspley-Guise, Aspley Heath, and Woburn Sands;—

And to all others whom it may concern.

WHEREAS by section 4 of the District Auditors Act, 1879, it is enacted that We, the Local Government Board, may from time to time assign to District Auditors their duties and the districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such duties or districts;

And whereas by an Order dated the 22nd day of March, 1909, We certified the appointment of Herbert Lyon as a District Auditor, and assigned to him the duties therein mentioned and the District in which he should act as Auditor, and which in the said Order was termed the "Hertfordshire Audit District";

And whereas the Joint Committee is an Authority whose accounts are subject to be audited by a District Auditor, and it is desirable that the duty of auditing the accounts of the Joint Committee and of their officers be assigned to the said Herbert Lyon:

NOW THEREFORE, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby order and prescribe that it shall, until We otherwise prescribe, be the duty of the said Herbert Lyon to audit the accounts of the Joint Committee, and of their officers, in conformity with the provisions contained in Article II of the above-cited Order; and that for the purposes of such audit the area within which the powers, authorities, and jurisdiction of the Joint Committee may be exercised shall
