PONT-Y-POOL UNION.

To the Guardians of the Poor of the Pont-y-pool Union;—

And to all others whom it may concern.

WHEREAS by the Relief Regulation Order, 1911 (hereinafter referred to as "the Order"), We, the Local Government Board, made provision with respect to the regulation of relief given by the Guardians of the Poor of the several Poor Law Unions in England and Wales, including the Pont-y-pool Union; and by Article XV of the Order We directed that, subject as therein provided, the Order should come into operation from and after the 31st day of March, 1912;

And whereas it is expedient that, in relation
