Amendment of Provisions for Cleansing and Disinfecting Carts, etc.

1.—(I.) The Swine-Fever Order of 1912, which revoked Article 6 of the Swine-Fever Order of 1911, and substituted another Article therefor, shall not apply to the District of the Local Authority of the county of Leicester or the borough of Loughborough, and within such District and Borough the Swine-Fever Order of 1911 shall apply as if the Swine-Fever Order of 1912 had not been made: 😳

(2.) The Local Authority may by Regulation extend the provisions of Article 6 of the Swine-Fever Order of 1911 to any van, cart or other vehicle used in connection with the conveyance of swine along any highway or thoroughfare from a market place, fairground or saleyard and to any crate, box, hamper, net, rope or other thing used for such conveyance, whether swine are removed therefrom or not.

(3.) The use of limewash may, by direction of the Local Authority, be omitted in the case of any cleansing and disinfection under the foregoing provisions.

Application.

2. This Order shall apply to the Districts of the Local Authorities of the County of Leicester and the Borough of Loughborough.

Commencement.

3. This Order shall come into operation on the eighth day of April, nineteen hundred and twelve:
