thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation, bearing date the twenty-ninth day of February, in the year one thousand nine hundred and twelve, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four, of the Act of the thirteenth and four-teenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of King Cross, of the new parish of the Holy Trinity, Halifax, of the new parish of Christ Church, Sowerby Bridge, and of the new parish of Saint Jude, Salterhebble, all in the county of York and in the diocese of Wakefield.

"Whereas by the authority of an Order of Her said late Majesty in Council, bearing date the twentieth day of November, in the year one thousand eight hundred and forty-five, and published in the London Gazette on the nineteenth day of the following month, two separate districts for spiritual purposes were constituted out of the parish of Halifax, in the said county of York, and at that time in the diocese of Ripon, but now in the said diocese of Wakefield, and one of such districts was named 'The District of King Cross.'

"And whereas by the authority of another Order of Her said late Majesty in Council, bearing date the thirtieth day of August, in the year one thousand eight hundred and sixtytwo, and published in the London Gazette on the fifth day of the following month, a district chapelry was assigned to the consecrated church of the Holy Trinity, situate in the said parish of Halifax, and the said district chapelry was named 'The District Chapelry of the Holy Trinity, Halifax.'

"And whereas by the authority of another Order of Her said late Majesty in Council, bearing date the fourteenth day of January, in the year one thousand eight hundred and sixty-nine, and published in the London Gazette on the following day, a district chapelry was assigned to the consecrated church called Christ Church, situate at Sowerby Bridge, in the said parish of Halifax, and the said district chapelry was named 'The District Chapelry of Christ Church, Sowerby Bridge.'

"And whereas by the authority of another Order of Her said late Majesty in Council, bearing date the twelfth day of January, in the year one thousand eight hundred and ninety-one, and published in the London Gazette on the sixteenth day of the same month, a district chapelry was assigned to the consecrated church of Saint Jude, situate at Salterhebble, and the said district chapelry was named 'The District Chapelry of Saint Judge, Salterhebble.'

"And whereas the said district of King Cross, the said district chapelry of the Holy Trinity, Halifax, the said district chapelry of Christ Church, Sowerby Bridge, and the said other Act of Parliament.

district chapelry of Saint Jude, Salterhebble, have become new parishes of the character contemplated by the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-seven, by the Act of the nineteenth and twentieth years of Her said late Majesty; chapter one hundred and four, and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four.

"And whereas it has been represented to us, and it appears to us to be expedient, that the boundaries of the said new parish of King Cross, the said new parish of the Holy Trinity, Halifax, the said new parish of Christ Church, Sowerby Bridge, and the said new parish of Saint Jude, Salterhebble, should be altered in the manner which is hereinafter mentioned.

"Now, therefore, with the consent of the Right Reverend George Rodney, Bishop of Wakefield (in testimony whereof he has signed and sealed this scheme or representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said new parish of King Cross, the said new parish of the Holy Trinity, Halifax, the said new parish of Christ Church, Sowerby Bridge, and the said new parish of Saint Jude, Salterhebble, shall be altered so that (firstly) all that portion of the said new parish of the Holy Trinity; Halifax, which is described in the first schedule hereunder written, and is delineated and set forth upon the map or plan hereunto annexed, and is thereon coloured blue, shall be dissevered from such new parish, and shall be annexed to and shall in future form part of the said new parish of King Cross; (secondly) all those portions of the said new parish of King Cross which are described in the second schedule hereunder written, and are delineated and set forth upon the map or plan hereunto annexed, and are thereon coloured green, shall be dissevered from such new parish, and shall be annexed to and shall in future form part of the said new parish of the Holy Trinity, Halifax; (thirdly) all that portion of the said new parish of King Cross which is described in the third schedule hereunder written, and is delineated and set forth upon the map or plan hereunto annexed, and is thereon coloured pink, shall be dissevered from such new parish, and shall be annexed to and shall in future form part of the said new parish of Saint Jude, Salterhebble; and (fourthly) all that portion of the said new parish of King Cross which is described in the fourth schedule hereunder written, and is delineated and set forth upon the map or plan hereunto annexed, and is thereon coloured yellow, shall be dissevered from such new parish, and shall be annexed to and shall in future form part of the said new parish of Christ Church, Sowerby Bridge.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbeforementioned Acts or of any of them or of any
