

Admiralty, 3rd April, 1912.

In pursuance of His Majesty's pleasure the following changes are to be made in regard to the wearing of officers' uniform and of decorations and medals, in lieu of those published in the London Gazette of the 22nd March, 1912 (page 2091):—

- (i) The full dress belt is to be worn by all officers with No. 3 dress—"Frock coat with epaulettes."
- (ii) In addition to the occasions specified in the regulations, No. 8 dress is to be worn in hot climates on the occasions prescribed for full dress, but only in the day-time and with helmet, full-dress belt, all decorations (including ribbons of Knights Grand Cross, under the shoulder strap, and orders worn round the neck) and medals.
- (iii) When No. 8 dress is worn in lieu of No. 1 or No. 3 dresses, the full-dress belt is to be worn.
- (iv) With No. 8 dress decorations and medals or ribbons of decorations and medals shall be worn as prescribed for Nos. 1, 3, 4, and 5 dresses, according to the occasion on which No. 8 dress is being worn.
