## (ADDITIONAL PROVISION).

(Extension of Limits of Supply; Borrowing Powers; Incidental Provisions.)

OTICE is hereby given, that application is intended to be made to Parliament in the present Session by the Urban District Council of Scunthorpe (hereinafter called "the Council") by petition for additional provision for leave to introduce into the Bill now pending in Parliament under the above name or title provisions and amendments to give effect to the following purposes (that is to say):

To extend the limits within which the Council are now authorized to supply water as defined by section 21 of the Scunthorpe Urban District. Gas and Water Act, 1899, so as to include the parish and urban district of Roxby-cum-Risby in the parts of Lindsey in the county of Lincoln, and to authorize the Council within the said parish and urban district to exercise all and the like powers, privileges and authorities for and in relation to the supply of water as they now have, and may exercise by virtue of the said Act of 1899 and the Scunthorpe Urban District Water Act, 1903, or which they may acquire under the Bill within their existing limits or any part thereof, and to demand, levy, take and recover rates and charges for or in respect of the supply of water within such extended limits.

To authorize the Council to borrow and reborrow further moneys for the purposes of the construction of a service tank, a rising main, and the mains and pipes necessary for the supply and distribution of water within the said parish and urban district on the security of the revenue of their water undertaking and the district fund and general district rate or any other rates and revenues leviable by or belonging to them or under their control and to apply all or any of such rates or revenues to the said purposes and to empower the Council to appropriate to the said purposes any unexpended moneys borrowed or raised and any moneys authorized to be borrowed or raised under the said Acts hereinbefore referred to.
