perpetual right of patronage of and presentation to the said benefice of Pebworth, now vested in him as aforesaid, should be transferred to and be vested in the Right Reverend Edgar Charles Sumner, now Bishop of the said diocese of Gloucester, and his successors in the same bishoprick.

"And whereas the said Edgar Charles Sumner, now Bishop of Gloucester, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Edgar Charles Sumner, Bishop of Gloucester, has executed this scheme as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of Pebworth which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the parish of Pebworth.

"Now therefore with the consent of the said Edleston Bonner Shekell (in testimony whereof he has signed and sealed this scheme) and with the consent of the said Edgar Charles Sumner, Bishop of Gloucester (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners for England, humbly recom-mend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Pebworth now vested in him the said Edleston Bonner Shekell as aforesaid, shall be transferred to the said Edgar Charles Sumner, Bishop of Gloucester, and his successors in the same bishoprick, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Edgar Charles Sumner, Bishop of Gloucester, and by his successors in the same bishoprick for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Gloucester.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the third and fourth years of Her said late Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the eighteenth day of April, in the year one thousand nine hundred and twelve, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the third and fourth years of Her said late Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Philip, Norbūry, situate in the new parish (sometime district chapelry) of Christ Church, Broad Green, Croydon, in the county of Surrey and in the diocese of Canterbury.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Philip, Norbury, situate as aforesaid.

"Now therefore, with the consent of the Right Honourable and Most Reverend Randall Thomas, Archbishop of Canterbury (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said new parish of Christ Church, Broad Green, Croydon, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Philip, Norbury, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Philip, Norbury.'
