**GOVERNMENT NOTICE (No. 126).**

Information having been received that an infectious or contagious disease, dangerous to mankind, to wit cholera, exists in the seaport of Mersina, in Asia Minor, it is hereby declared that the seaport of Mersina is an infected place, within the meaning of Article 1 of the Regulations made under the Fourth Sanitary Ordinance, 1908, republished by Government Notice No. 207 of the 13th July, 1911, and amended by Government Notices No. 224 of the 29th July, 1911; No. 252 of the 22nd August, 1911; No. 294 of the 28th September, 1911; No. 316 of the 13th October, 1911; and No. 74 of the 22nd March, 1912.
