WELSH INSURANCE COMMISSION.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the Joint Committee of the several bodies or Commissioners appointed for the purposes of Part I of the National Insurance Act, 1911, acting jointly with the Welsh Insurance Commissioners constituted under that Act, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by sections 7 and 65 of the National Insurance Act, 1911, and by the National Insurance (Joint Committee) Regulations, 1912, to make regulations as to the payment and collection of contributions payable by an employer under section 4 (4) of the Act.
