PART II (UNEMPLOYMENT INSURANCE).

The Board of Trade hereby give notice, pursuant to section 113 (1) of the National Insurance Act, 1911, that they propose to make a special order excluding the following employments from the occupations which are to be deemed employment in an insured trade for the purposes of Part II of the Act (Unemployment Insurance), that is to say:---

1. The drivers or attendants of any vehicle. 2. Stablemen or other workmen employed in tending horses or to clean any vehicle.

3. Woodcarvers.

4. Workmen employed in the manufacture and fitting of upholstery for the purpose of the construction, alteration, repair or decoration of buildings, ships, boats or other craft.

5. Workmen employed in the manufacture of fittings of leather or celluloid for cycles or motor cycles.

MOTOR CAR ACT, 1903.

Regulations under Section 9 (1). COUNTY OF EAST SUSSEX.

PARISH OF LINDFIELD.

To the County Council of East Sussex ;-And to all others whom it may concern.

WHEREAS by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in Regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas the County Council of East Sussex, having made application to Us to make a Regulation in pursuance of the said subsection putting the above-mentioned provisions of that sub-section in force within the limits comprising certain roads or parts of roads within the Parish of Lindfield, We directed a Local Inquiry to be held into the matter by one

of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon :

NOW THEREFORE, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:-

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the parts of roads within the said Parish which are specified in the Schedule hereto.

ARTICLE II.—These Regulations shall come into operation on the first day of July, one thousand nine hundred and twelve.

SCHEDULE.

So much of the main road from Hayward's Heath to Croydon passing through the village of Lindfield as extends from a point opposite the north side of the Town Pond to a point opposite the north side of Batchelors Lane, otherwise known as Denmans Lane;

So much of the main road above-mentioned as extends from a point 75 yards south of the south entrance to the Church Yard of the Parish Church to a point 90 yards south of the junction of the main road with Spring Lane on Town Hill; and

So much of the road from Lindfield to Lewes as extends from its junction with the main road aforesaid to a point opposite the north-west side of the public footpath situate on the north of Lindfield Common.
