Notice is hereby given, pursuant to the provisions of Section 113 of the National Insurance Act, 1911, and of the Ninth Schedule to the said Act, that the Joint Committee of the several bodies of Commissioners appointed for the purposes of Part I of the said Act, and the Insurance Commissioners, the Scottish Insurance Commissioners, the Irish Insurance Commissioners, and the Welsh Insurance Commissioners constituted under the said Act, acting jointly, propose to make a further Special Order under paragraph (i) of Part II of the First Schedule to the said Act, specifying certain classes of employment (being classes of employment additional to those specified in the draft Special Order, of which notice was published on 7th June, 1912) as being of such a nature that they are ordinarily adopted as subsidiary employment only and not as the principal means of livelihood.

#### NATIONAL INSURANCE ACT, 1911.

(1 and 2 George V, ch. 55).

The Joint Committee of the several bodies of Commissioners appointed for the purposes of Part I of the National Insurance Act, 1911, and the Insurance Commissioners constituted under the said Act, acting jointly, hereby give notice that, pursuant to the provisions of the National Health Insurance (Special Orders Acceleration) Order, 1912, they have made a

Provisional Special Order in the terms of the draft Special Order under paragraph (k) of Part II of the First Schedule to the said Act (of which they have already published notice) to the effect that employment as a member of the crew of a fishing vessel where the members of the crew are remunerated by shares in the profits or the gross earnings of the working of the vessel, and are entitled to receive a share in those profits or earnings during periods of sickness or temporary disablement, in accordance with any custom or practice prevailing at the commencement of the Act at any port within the limits of the ports of Penzance and St. Ives (as defined in the Order in Council made the 24th day of March, 1902, under section 373 of the Merchant Shipping Act, 1894, for making regulations for the registry, lettering, and numbering of British sea-fishing boats), shall not be employment within the meaning of Part I of the National Insurance Act.
