

ORDER OF THE BOARD OF
AGRICULTURE AND FISHERIES.

(DATED 26TH JULY 1912.)

LANCASHIRE AND DISTRICT (FOOT-
AND-MOUTH DISEASE) ORDER OF
1912 (No. 12).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Modification of Order.

1. The Lancashire and District (Foot-and-Mouth Disease) Order of 1912 (No. 9) (hereinafter referred to as "the principal Order") is hereby further modified in manner hereinafter appearing.

*Holding of Markets and Sales of Animals for
Immediate Slaughter at Liverpool.*

2.—(1.) The prohibition of markets and sales contained in Article 7 of the principal Order shall not apply to a market or sale at the Corporation Market, known as Stanley Market, in the county borough of Liverpool, of animals intended for immediate slaughter if the market or sale is authorised by the Local Authority under this Order.

(2.) The Local Authority shall cause at least one Veterinary Inspector to attend at every market or sale authorised under this Order, and examine the animals exposed thereat.

(3.) An animal which has been moved under Article 5 (1) of the principal Order to a railway station or landing-place in the above-mentioned borough may be moved from such railway station or landing-place to any market or sale authorised under this Article for the purpose of exposure for sale thereat if accompanied by a Movement Licence authorising such movement granted by an Inspector of the Local Authority of the county borough of Liverpool.

(4.) An animal may be moved from any such market or sale only if accompanied by a Movement Licence granted by an Inspector of the Local Authority of the county borough of Liverpool, and only to a slaughter-house in Zone I where the animal shall be detained until it is slaughtered.

Alteration of Limits of Prohibited Area.

3. The areas described in the Schedule hereto shall be substituted for the Prohibited Area No. 1 described in the Second Schedule to the principal Order, and that Order shall be read and have effect accordingly.

Short Title, etc.

4. This Order may be cited as the LANCA-SHIRE AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1912 (No. 12), and shall be read with the principal Order.

SCHEDULE.

1. An Area comprising so much of the county borough of Liverpool as lies within the following boundary, but excluding any roads or railways forming such boundary:—

A line commencing at the junction of Russian Drive and Green Lane and proceeding thence in a south-easterly direction along the latter lane to its junction with Lister Drive, thence in a south-westerly direction along the latter drive to and across the bridge over the London and North-Western Railway (Edge Hill and Bootle Branch) to the south-western boundary of that railway, thence following the railway siding to Stanley Market, thence along the boundary of the market abutting on St. Anne's Church (excluding any part of the market) to its junction with Prestcott Road, thence in a westerly direction along Prestcott Road to the county borough boundary, thence in north-easterly, northerly and north-westerly directions along that boundary to a point in Towan Row opposite Hartington Road, thence in a south-westerly direction along the latter road to its junction with Eaton Road, thence in a south-easterly direction along the latter road to its junction with Alder Road, thence in a south-westerly direction along the latter road to Black Horse Lane, thence in a north-westerly direction along the latter lane to its junction with Moss Lane, thence in a northerly direction along the latter lane to its junction with Kremlin Drive, thence in a south-westerly direction along the latter drive and Russian Drive to the point of commencement.

1a. An Area comprising so much of the county borough of Liverpool as lies within the following boundary, but excluding any roads forming such boundary:—

A line commencing at the junction of Bridge Road and Rose Lane, and proceeding thence along the latter lane to its junction with Allerton Road, thence in a south-easterly direction along the latter road to its junction with the main road across Calderstones Park, thence in a north-easterly direction along the latter road to its junction with Calderstones Road, thence in a northerly direction across Calderstones to Menlove Avenue, thence in a north-westerly direction along the latter avenue to its junction with Queen's Drive, thence in a south-westerly direction along the latter drive to the north-eastern boundary of the London and
