North-Western Railway (Edge Hill and Garston Line), thence south-easterly along that boundary and along Bridge Road to the point of commencement.

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 26TH JULY 1912.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

- 1. Cattle, sheep, goats and swine shall not be moved into the showyard of the Welsh National Agricultural Society's Show, to be held at Swansea, in the county of Glamorgan, on the 5th and 6th days of August, if they have been in England at any time since the 30th day of June last.
- 2. Cattle, sheep, goats and swine shall not be moved into such showyard unless they are accompanied by a declaration signed by the owner or exhibitor thereof stating that the animals, which shall be specified in the declaration, have not been in England, except as hereinafter provided, at any time since the 30th day of June last. The declaration shall be produced on entry of the animals into the showyard to a person appointed for the purpose by the Society and be retained by him.
- 3. For the purposes of this Order cattle, sheep, goats or swine which have been moved through a part of England by railway shall not by reason of such movement be deemed to have been in England.

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 27TH JULY 1912.)

DURHAM AND NORTHUMBERLAND (FOOT - AND - MOUTH DISEASE) ORDER OF 1912 (No. 8).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Modification of Order.

1. The Durham and Northumberland (Footand-Mouth Disease) Order of 1912 (No. 5) and the Durham and Northumberland (Foot-and-Mouth Disease) Order of 1912 (No. 7) (hereinafter referred to as Order No. 5 and Order No. 7) are hereby modified in manner hereinafter appearing.

Extension of Limits of Prohibited Area.

2. The Area described in the First Schedule hereto shall be a Prohibited Area for the purposes of the above-mentioned Orders, and shall be substituted for the Prohibited Area numbered 6 in the Schedule to Order No. 7.

Application of Restrictions to a new Zone.

3. The Area described in the Second Schedule hereto (hereinafter referred to as Zone IV) shall cease to form part of Zone IIIa, and shall be subject to the following provisions of this Order.

Movement out of Zone IV and Movement into or within such Zone.

- 4.—(1.) No animal shall be moved out of or into, or be moved along, over, or across a highway or thoroughfare within Zone IV except in accordance with the following provisions of this Order.
- (2.) No animal shall be allowed by the owner or person in charge thereof to stray upon a highway or thoroughfare in Zone IV.

Movement into, within, or out of Zone IV for Immediate Slaughter.

5.—(1.) An animal may, subject as provided in Orders No. 5 and No. 7 be moved by railway without a Licence from premises not within any District which is for the time being a Scheduled District for the purposes of an Order of the Board relating to Foot-and-Mouth Disease, or from any part of the
