ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 20TH AUGUST 1912.)

DURHAM AND NORTHUMBERLAND (FOOT-AND-MOUTH DISEASE) ORDER OF 1912 (No. 13).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Amendment of Orders.

1. The Durham and Northumberland (Footand-Mouth Disease) Order of 1912 (No. 9) (hereinafter referred to as "the principal Order ") and the Durham and Northumberland (Foot-and-Mouth Disease) Orders of 1912 (No. 11) and (No. 12)—all of which Orders are hereinafter referred to as "the existing Orders"-are modified in manner hereinafter appearing.

Prohibited Areas.

2.--(1.) All the Prohibited Areas described in the Second Schedule to the principal Order, except that numbered 1a (in the Chollerton District)—as altered by the Durham and Northumberland (Foot-and-Mouth Disease) Order of 1912 (No. 12)-shall cease to be Prohibited Areas.

(2.) No animal shall be moved out of any of the Areas described in the First Schedule hereto except in accordance with paragraph (2) of Article 6 of the Durham and Northumberland (Foot-and-Mouth Disease) Order of 1912 (No. 11).

Alteration of Limits of Zone I.

3. The Zone I described in the Second Schedule to this Order shall be substituted for the Zone I described in the Second Schedule to the principal Order.

Withdrawal of Movement Restrictions from Zones Ia, Ib, and II.

4. All restrictions on movement of animals out of Zone Ia, Zone Ib, and Zone II shall cease to operate.

Holding of Markets, &c.

5. A market, fair or sale of animals may be held in Zone Ia, Zone Ib, or Zone II, subject to the conditions specified in paragraphs (4) and (5) of Article 2 of the principal Order.

Commencement.

6. This Order shall come into operation on the twenty-third day of August, nineteen hundred and twelve.

Short Title.

7. This Order may be cited as the DURHAM Northumberland (FOOT-AND-MOUTH AND DISEASE) ORDER OF 1912 (No. 13), and shall be read with the existing Orders.
