EXPLOSIVES ACT, 1875.

FACTORY AND WORKSHOP ACT, 1901.

The Secretary of State for the Home Department hereby gives notice, pursuant to Section 3 (3) of the Rules Publication Act, 1893, that on the 23rd August, 1912, he made an Order under Section 116 of the Factory and Workshop Act, 1901, applying the provisions of that Section with modifications to Shipbuilding Yards.

This Order re-enacts the previous Order of the 30th December, 1909 (which applied to Shipbuilding Yards so far as concerned the work of platers, riveters and caulkers), and extends it to the work of all persons employed in Shipbuilding Yards on the building or repairing of a ship.
