ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 4TH OCTOBER 1912.)

LANCASHIRE (FOOT - AND - MOUTH DISEASE) ORDER OF 1912 (No. 7).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Alteration of Limits of Zones and Prohibited Areas.

1.—(1.) The Lancashire (Foot-and-Mouth Disease) Order of 1912 and the Lancashire (Foot-and-Mouth Disease) Orders of 1912 (Nos. 2-6) shall be read and have effect as if the Zones Ia and Ib and the Prohibited Areas described in the First and Second Schedules hereto were substituted for the Zone I and the Prohibited Areas therein to which those Orders refer, and as if the Zone II described in the Third Schedule hereto were substituted for the Zone II to which those Orders refer.

(2.) The Scheduled District for the purposes of the above-mentioned Orders shall comprise only the Zones Ia and Ib and the Prohibited Areas therein. and the Zone II, as described in the Schedules hereto.

Commencement.

2. This Order shall come into operation on the fifth day of October, nineteen hundred and twelve.

Short Title, &c.

3. This Order may be cited as the Lancashire (Foot-and-Mouth Disease) Order of 1912 (No. 7), and shall be read with the Orders referred to in Article 1.

FIRST SCHEDULE.

Zone Ia.

The Area described as Prohibited Area No. 1 in the Schedule to the Lancashire (Foot-and-Mouth Disease) Order of 1912 (No. 6), but excluding the Prohibited Area therein hereinafter described.

Prohibited Area in Zone Ia.

An Area in the administrative county of Lancaster comprising the parish of Ribbleton, and such parts of the parishes of Grimsargh with Brockholes, Fulwood, and Haighton as lie within a boundary commencing at the junction of Long Sight Lane with the road running southward to Fir Tree Farm, and proceeding thence in a southerly direction following that road and the road and footpath in continuation thereof to the footbridge over Tun Brook, thence following the course of that Brook to its confluence with the River Ribble, thence following the western bank of that river to the eastern boundary of the county borough of Preston, thence in a northerly direction following that boundary to the southern boundary of the parish of Fulwood near Sion Hill, thence following the main Preston and Longridge Road to its junction with Gamull Lane, thence following the last-named lane and the main road in continuation thereof (via Fulwood Row) to the junction of the latter with the footpath leading westward to Fernyhalgh Bridge, thence following that footpath to the before-named bridge, thence in an easterly direction following the course of Savick Brook to Londonderry Bridge, thence generally in an easterly direction following the main roads (via Slater's Farm, Siddall Farm, and Brown's Farm) to Whittingham Junction, and thence following Long Sight Lane to the point of commencement, but excluding any roads, footpaths or streams forming parts of such boundary.

SECOND SCHEDULE.

Zone Ib.

The Area described as Prohibited Area No. 2 in the Schedule to the Lancashire (Foot-and-Mouth Disease) Order of 1912 (No. 6), but excluding the Prohibited Area therein hereinafter described.

Prohibited Area in Zone Ib.

An Area in the administrative county of Lancaster comprising such parts of the parishes of Heapey, Wheelton, and Withnell as lie within a boundary commencing at the junction of Chapel Lane with Sandy Lane and proceeding thence in a northerly direction following the last-named lane and Kenyon's Lane to the southern bank of the Leeds and Liverpool Canal, thence in a north-easterly direction following that bank to the Bridge near Brown House Farm, thence in a south-easterly direction following the footpath and road (via Wheelton Stocks) and Buckholes Lane to the junction of the latter with Harbour Lane, thence in a south-westerly and north-westerly direction, successively, following Harbour Lane, Briers Brow, the footpath (via Roscoe Fold and Heapey), and Chapel Lane to the point of commencement, but excluding any road or footpath forming part of such boundary.

THIRD SCHEDULE.

Zone II.

The Zone described as Zone I in the Schedule to the Lancashire (Foet-and-Mouth Disease) Order of 1912 (No. 4), but excluding
