### ANIMALS (LANDING FROM IRELAND) AMENDMENT ORDER OF 1912 (No. 11).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

## Landing for Slaughter at Foreign Animals Wharves.

1. Notwithstanding the provisions of Article 22 of the Foreign Animals Order of 1910, and the Animals (Landing from Ireland) Order of 1912, cattle, sheep, goats, or swine brought from Ireland and put on board at a port specified in the First Schedule to this Order may be landed at any Foreign Animals Wharf specified in the Second Schedule to this Order for the purpose of being slaughtered in such wharf if such landing is authorised by the Superintendent of the wharf or the person in charge of the wharf. Animals landed under this Order or any Order hereby revoked shall be subject to the provisions of the Foreign Animals Order of 1910, which relates to animals landed at a foreign animals wharf.

#### Revocation.

2. The Animals (Landing from Ireland) Amendment Order of 1912, and the Animals (Landing from Ireland) Amendment Order of 1912 (Nos. 2-10) are hereby revoked as from the commencement of this Order.

#### Commencement.

3. This Order shall come into operation on the seventh day of October, nineteen hundred and twelve.

#### Short Title.

4. This Order may be cited as the Animals (Landing from Ireland) Amendment Order of 1912 (No. 11).
