HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 8th day of October, 1912, in the words following, viz.:—

"Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, and other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas by Order in Council of His late Majesty bearing date the 21st day of

December, 1907, sanction was given to the payment of an allowance at the rate of two shillings and sixpence a day to officers of Your Majesty's Royal Marine Force employed as Instructors of Wireless Telegraphy, and an allowance of one shilling a day to such officers when employed as Assistants for Wireless Telegraphy duties in Your Majesty's Fleet:

"And whereas we are of opinion that in order to obtain a sufficient number of suitable candidates for such appointments it is necessary that these allowances should be increased:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to authorize:—

- "(a) The grant of an allowance of three shillings and sixpence a day to officers of the Royal Marines employed as Instructors of Wireless Telegraphy in such appointments as we may see fit and in such numbers as may from time to time be determined by us with the concurrence of the Lords Commissioners of Your Majesty's Treasury; and
 - "(b) The grant of an allowance of two
