"And whereas by an Order in Council of His late Majesty bearing date the fifteenth day of June, 1901, provision was made for the payment of an allowance of 7d. a day to the Senior Chief or other Armourer in Torpedo Schools in consideration of the responsibility devolving upon them:

"And whereas the Armourer ratings in the Torpedo Schools have been replaced by Electricians:

"We beg leave humbly to recommend that Your Majesty will be graciously pleased by Your Order in Council to sanction the continuance of this allowance of 7d. a day to the Senior Chief or other Electrician in each Torpedo School:

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

WHEREAS by the Burial Act, 1855, it was, amongst other things, enacted that it should be lawful for His Majesty, by and with the advice of His Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, should or should not have arrived), as to His Majesty, with such advice as aforesaid, might seem fit:

And whereas an Order in Council dated the 3rd day of October, 1911, was made directing the discontinuance of burials with certain exceptions in the Parish Churchyard of Saint Giles, Holme, in the County of Huntingdon, after the 31st day of December, 1911:

And whereas by an Order in Council of the 17th day of January, 1912, the time appointed for the discontinuance of burials in the said Parish Churchyard was postponed to the 31st day of March, 1912:

And whereas by an Order in Council of the 28th day of March, 1912, the time appointed for the discontinuance of burials in the said Parish Churchyard was further postponed to the 30th day of June, 1912:

And whereas by an Order in Council of the
