GISBURNE HOUSE INDUSTRIAL SCHOOL FOR GIRLS, WATFORD.

Provisional Certificate.

The Secretary of State for the Home Department hereby gives notice that he has this day issued a provisional Certificate under the provisions of the Children Act, 1908 (8 Edw. 7, cap. 67), for the premises known as Gisburne House, Watford, in the county of Hertford, with a view to the reception therein of girls committed to an Industrial School in pursuance of the Children Act, 1908, or of the Elementary Education Act, 1876 (39 and 40 Vic., cap. 79).

The Certificate, which is temporary, authorises the reception into the School of twenty girls, pending the completion of certain structural alterations to the building, when a permanent Certificate for the full number of girls will be issued.
