A Zone comprising:

The petty sessional divisions of South Shields and Sunderland (including its detached part), the borough of Jarrow, the parishes of Silksworth, East and Middle Herrington, Warden Law, Houghton-le-Spring, Newbottle, West Herrington, Painshaw, South Biddick, Bournmoor, Lambton, Barmston, Washington, Usworth, and Heworth, and such parts of the parishes of Harraton, Birtley, and Lamesley, as lie to the east of the North-Eastern Railway line running from Durham to Gateshead (*via Chester-le-Street*), in the administrative county of Durham;

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 17TH OCTOBER 1912.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows: The county boroughs of Gateshead, South Shields, and Sunderland;

The borough of Wallsend, and such part of the parish of Longbenton as lies to the south and east of the North-Eastern Railway line running from Newcastle-upon-Tyne to Tynemouth (via Gosforth and Longbenton), in the administrative county of Northumberland; and

The county borough of Newcastle-upon-Tyne (except the parishes of Fenham and Benwell).

Prohibited Areas in Zone I.

1. An Area comprising the parishes of Byker and Walker, in the county borough of Newcastle-upon-Tyne.

2. An Area in the administrative county of Durham comprising the parishes of Hylton and Boldon, such parts of the parishes of Usworth and Boldon Colliery as lie to the east of the North-Eastern Railway line from Washington to Pelaw Station (Heworth) and such part of the parish of Monkton (excluding its detached part) as lies to the south of the road from South Shields to North Leam.
