ANIMALS (LANDING FROM IRELAND) AMENDMENT ORDER OF 1912 (No. 13).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Amendment of Article 3 of the Animals (Landing from Ireland) Amendment Crder of 1912 (No. 12).

1. For Article 3 of the Animals (Landing

from Ireland) Amendment Order of 1912 (No. 12) the following Article is substituted:

"Detention and Examination of the Cattle Landed.

3.—(1.) Cattle landed under this Order shall remain in a reception-lair until a Veterinary Inspector of the Board certifies that all the cattle then in the reception-lair are free from Foot-and-Mouth Disease, which certificate shall not be given until the expiration of ninety-six hours from the time of the departure from Ireland of the vessel in which the cattle were conveyed.

(2.) Until the issue of the certificate the restrictions on access to a reception-lair which are contained in the Foreign Animals Order of 1910 shall apply to the lair ir which the animals are detained."

Short Title.

2. This Order may be cited as the Animals (Landing from Ireland) Amendment Order of 1912 (No. 13).
