

stations for producing or generating, transforming, storing and distributing electricity (namely):—

(a) A piece of land in the parish of Herne Bay, in the county of Kent, containing 1 rood 17 perches and 14 yards or thereabouts belonging or reputed to belong to the Company, situate on the north side of Salts-lane and the south side of King-street at its junction with King's-road, on which or on some part whereof there are at present standing certain retorts, gasholders, purifiers and other works of the Company.

(b) A piece of land in the parish of Herne Bay, in the county of Kent, containing 1 acre 1 rood 1 perch and 22 yards or thereabouts, belonging or reputed to belong to the Company, situate on the north side of King-street aforesaid and on the west side of Beach-street and the south side of Hanover-street, on which or on some part whereof there are now standing certain gasholders, meter and governor houses, and other works of the Company.

6. To authorize the Company within the area of supply to lay down, place, erect, maintain and renew electric lines, pipes, apparatus, street boxes, meters and other works and things requisite for supplying electricity and for the foregoing purposes and other the purposes of the intended Act to open, break up, or otherwise interfere with streets and roads (whether dedicated to the public use or not), including the following streets not repairable by the local authority:—

Albany-drive, Alexandria-drive, Arkley-road, Beaumont-street, Beacon Hill-parade, Belmont-street, Bird's-lane, Bognor-drive, Bournemouth-avenue, Buller's-avenue, Carlton-hill, Central-avenue, Chamberlain-drive, Cliff-avenue, Clarendon-street, Clarendon-square, Claremont-street, Cliff Sea-grove, Clifftown-gardens, Crown Hill-road, Culverden-road, three un-named streets on the Station-avenue Estate, Douglas-road from No. 62 to its junction with Mayfield-road, Fernlea-avenue, Fitzgerald-avenue, Fleetwood-avenue, Glen-avenue from "Glenside" to its junction with Grange-road, Gordon-road from "Brock Villa" to its termination at Culverden-road, Harcourt-drive, Hill Top-road, Ivanhoe-road, Linden-avenue, Leighville-drive, Mayfield-road, Montagu-street, Oakdale-road from No. 28 to its junction with Mayfield-road, Oxenden-park, Oxenden-square, Queen's-avenue, Queensbridge-drive, Ridgway Cliff, Sandown-drive, Salisbury-drive, Selsea-avenue, South Cliff-drive, Spa-esplanade, Spencer-road, St. Anne's-drive, St. George's-avenue, St. Helena-grove, St. Louis-grove, Stanley-road from Eagland Villas to its termination at Spencer-road, Sunnyhill-road, The Broadway, Thurlow-avenue, Tyndale Park from No. 16 to its junction with Mickleburgh-hill, Westcliff-drive, Westcliff-gardens, West Hill-drive, York-road, road between Beltinge-road and Bird's Corner.

7. To specify the names of the streets in which it is proposed that electric lines shall be laid down within a period to be specified by the intended Act so as to include all or some of the following streets:—

High-street from William-street to Brunswick-street, William-street from High-street to Marine-parade, Mortimer-street from William-street to Richmond-street, Brun-

wick-street from High-street to Marine-parade, Dolphin-street, Richmond-street from High-street to Marine-parade, Beach-street from High-street to termination, Market-street, Telford-street.

8. To empower the Company to make and recover rates, rents and charges for the supply of electricity and to prescribe the maximum price to be charged for such supply and to enact provisions in regard to (amongst others) the following matters:—The erroneous registration by meters; power for the Company to construct and maintain in or under streets substations, transforming stations or other works in connection with their electricity undertaking, to provide means of access and approach thereto; to enable the Company to refuse to supply gas or electricity to persons in debt to them; the giving of notices and other matters.

9. To confer upon the Company all or some of the powers of the Electric Lighting Acts, 1882 to 1909, and enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would or might interfere with any of the objects of the intended Act, and to confer all other rights and privileges necessary for carrying such objects into effect.

10. To enable the Company to purchase, provide, sell, let for hire or otherwise deal in and fix motors, pipes, fittings, engines, stoves, fuses, switches, lamps, wires, dynamos and other apparatus incidental to the supply or use of electricity, and to exclude the same from liability to distress, or to be taken in execution or in proceedings in bankruptcy.

11. To change the name of the Company and to empower the Company to raise further capital by the creation and issue of new ordinary or preference shares or stock, and by borrowing on mortgage or by debenture stock, or partly in one mode and partly in another, and in such proportions as may be prescribed or authorized by the intended Act, and to attach to such new ordinary or preference shares, stock, mortgages or debenture stock, such rate of dividend or interest, and such other rights, privileges and conditions as may be prescribed or authorized as aforesaid, and to empower the Company to apply to the purposes of the intended Act and to the general purposes of their undertaking any moneys which they are already authorized to raise and to make provision for the accounts of expenditure for gas and electricity purposes and the apportionment of the capital required for the gas and electricity undertakings.

12. To incorporate, alter, amend or repeal all or some of the provisions contained in the Order and in the Herne Bay Gas Acts, 1899 to 1912, and to incorporate and apply with or without modification, or render inapplicable all or some of the provisions of the following public Acts:—The Lands Clauses Acts; the Gasworks Clauses Act, 1847, and the Gasworks Clauses Act, 1871; and all Acts amending those Acts respectively.

And notice is hereby also given, that on or before the 17th day of December next printed copies of the intended Act will be deposited in the Private Bill Office of the House of Commons.
