

of Merthyr Tydfil crosses the centre of the said road and terminating by a junction with Work No. 6, authorized by the Merthyr Tydfil Corporation Water Act, 1911, at a point on the western boundary of the enclosure numbered 2686 on the $\frac{1}{2500}$ Ordnance Map of the county of Glamorgan (2nd edition, 1900) Sheet XIX. 15 distant 7 yards or thereabouts measured in a southerly direction from the north-west corner of the said enclosure, which aqueduct, conduit or one or more line or lines of pipes will be situated in the parishes of Llanwonno and Merthyr Tydfil.

Work No. 2.—An aqueduct, conduit or one or more line or lines of pipes commencing by a junction with the aqueduct Work No. 12, authorized by the Pontypridd Waterworks and Tramroad Act, 1908, in Cilfynydd-road, at a point 457 yards or thereabouts, measured in a straight line in a southerly direction from a point in the centre of the said public road opposite the centre of Cross-street, and terminating in the Nant-Cae-dudwg at or near the point of junction of the Nant-Cae-dudwg and the River Taff, which aqueduct, conduit or one or more line or lines of pipes will be wholly situated in the parish of Pontypridd.

Work No. 3.—An aqueduct, conduit or one or more line or lines of pipes commencing in the service reservoir Work No. 6 authorized by the Pontypridd Waterworks (Amendment) Act, 1909, and terminating by a junction with the aqueduct Work No. 1 authorized by the Pontypridd and Rhondda Water Act, 1910, in the road known as Aely-Bryn-road at a point 34 yards or thereabouts measured in a straight line in a south-easterly direction from the point of intersection of the centre line of the Nant-y-Ffin with the centre line of the said road which aqueduct, conduit or one or more line or lines of pipes will be wholly situated in the parish of Pontypridd.

Work No. 4.—An aqueduct, conduit or one or more line or lines of pipes commencing in the Trebanog reservoir of the Board, situated in the enclosure numbered 1,744, on the $\frac{1}{2500}$ Ordnance Map of the County of Glamorgan (2nd Edition, 1900) Sheet XXVII. 16 and terminating in the centre of the Trebanog-road at a point 75 yards or thereabouts, measured in a straight line in a southerly direction from the point at which the boundary of the Rhondda Urban District crosses the centre of the said road, which aqueduct, conduit or one or more line or lines of pipes will be situated in the parishes of Rhondda and Llantrisant.

To empower the Board to deviate laterally and vertically from the lines and levels of the intended works shown on the plans and sections hereinafter mentioned, to the extent shown on the said plans and sections, or to be defined in the intended Act.

To enable the Board to exercise in relation to the said works all or any of the powers of the Pontypridd and Rhondda Water Act, 1910 (hereinafter called "the Act of 1910"), with respect to the construction and maintenance of works and of subsidiary and ancillary works.

To authorize the Board to break up, cross, divert, alter, or stop up, remove, or otherwise interfere with, permanently or temporarily, all roads, highways, streets, footpaths, or places, pipes, sewers, drains, rivers, streams, canals,

watercourses, tramways, tramroads, railways, and telegraphic and telephonic apparatus which it may be necessary to interfere with in constructing and maintaining the intended works, or for other the purposes of the Bill, and to extend to the intended works all or any of the provisions of the Waterworks Clauses Acts, 1847 and 1863.

To authorize the Board to purchase and take or use either compulsorily or by agreement, and to hold lands, houses, and other property for the purpose of the aforesaid works or other the purposes of the water undertaking of the Board, or of the intended Act, and also to take compulsorily or by agreement easements and rights in, under, over, or upon lands and other property without being required to purchase such lands or property.

To authorize the Board to acquire by compulsion or agreement, and to hold for the purposes of their water undertaking, in addition to the lands they are already authorized to acquire, the lands hereinafter described (that is to say):—

(a) A piece or parcel of land containing by admeasurement 555 square yards or thereabouts, abutting on the eastern boundary of the buildings known as Hooper's-terrace, and situated in the enclosure numbered 1658 on the $\frac{1}{2500}$ Ordnance Map (second edition, 1900) of the county of Glamorgan, Sheet XXVII. 16 in the parish of Rhondda and county of Glamorgan.

(b) A piece or parcel of land, containing by admeasurement 190 square yards or thereabouts, abutting on the public road between Pontypridd and Llantwit Fardre, and situated in the south-eastern corner of the enclosure numbered 1,337 on the $\frac{1}{2500}$ Ordnance Map (second edition, 1900) of the county of Glamorgan, Sheet XXXVI. 3 in the parish of Pontypridd and county of Glamorgan.

To exempt the Board from the provisions of the Lands Clauses Consolidation Act, 1845, relating to superfluous lands and to make other amendments in the Lands Clauses Acts in their application to the intended Act, and to make provision for limiting the amount of purchase money or compensation in the case of recent buildings or alterations or recently-created interests therein, and as to the payment of costs in certain cases of disputed compensation by persons failing to send in sufficient particulars of their claims.

To provide that the said intended works shall for all purposes form part of the water undertaking of the Board.

To extend the periods limited by the Act of 1910 for the compulsory purchase of lands or any easement or right in or over lands under and the completion of works authorized by the Pontypridd Waterworks and Tramroad Act, 1908, the Pontypridd Waterworks (Amendment) Act, 1909, and the Act of 1910, and for that purpose to repeal or amend any provisions of those Acts inconsistent with such extension.

To revive and empower the Board to exercise the powers granted to them, and to extend the periods limited by the Act of 1910 for the compulsory purchase of lands or any estate, interest, easement, or right in or over lands authorized to be acquired under that Act, including the lands in the parish of Pontypridd, and the rights, interests, and easements therein or thereover referred to in Section 50 (for the
