NOTICE is hereby given, that application is intended to be made to Parliament in the next Session by the Urban District Council of the Urban District of Broadstairs and St. Peters in the County of Kent (hereinafter called "the Council") for leave to bring in a Bill (hereinafter called "the Bill") for all or some of the following purposes, that is to say:—

1. To empower the Council to make and maintain the following street improvements and other works in the parish of St. Peter Intra and Urban District of Broadstairs and St. Peters together with all necessary and proper approaches, junctions, works, and conveniences connected therewith or incidental thereto, namely:—

Work No. 1.—A widening and improvement of High-street, Broadstairs, on the South side thereof, between Nuckell's-place .and Charlotte-street.

Work No. 2.—A widening and improvement of High-street, Broadstairs, on the South side thereof between Raglan-place and the back entrance to the Crown Inn.

Work No. 3.—A widening and improvement of High-street, Broadstairs, on the South side thereof, between the premises known as 29, High-street and Belvedereroad.

Work No. 4.—A widening and improvement at the corner of Charlotte-street and York-street, on the Western side of Charlotte-street and on the North-western side of York-street, between No. 4, Charlotte-street and the premises known as Chandos House, York-street.

Work No. 5.—A widening and improvement of Nelson-place, Crow Hill, and Stoneroad, on the East side thereof, between Rectory-road and the South side of the premises known as "Woodstock," Stone-road.

mises known as "Woodstock," Stone-road. Work No. 6.—A widening and improvement of High-street, St. Peter's, on the North-west side thereof, between Ranelaghgrove and the premises known as "Thurso," High-street.

2. To authorize the Council to break up, alter, widen, divert, stop up (either temporarily or permanently) and interfere with streets, roads, highways, footpaths, watercourses, sewers, drains, pavements, mains, pipes, wires, telegraphs, telephones, and apparatus within the parish, district, and County aforesaid, for the purposes of constructing and maintaining the proposed works or any of them or otherwise for the purposes of the intended Act.

3. To empower the Council for the purposes of the proposed works, for the purpose of providing frontage to the streets intended to be widened, and for other the purposes of the intended Act, to purchase or acquire by compulsion or agreement or to take on lease lands, houses, or buildings in the parish, district and County aforesaid, and to acquire by compulsion or agreement rights or easements in, over, or connected with any lands, houses, or buildings.

4. To exempt the Council from the operation of Section 92 of the Lands Clauses Consolidation Act, 1845 (so as to enable them to acquire parts only of certain properties), and the provisions of that Act relating to superfluous lands, and to make other amendments in the Lands Clauses Acts in their application to the intended Act, and to confer powers upon the Council with reference to the retention, sale, and disposal of lands acquired by them.

To make special provision with regard to the amount of compensation to be paid in respect of the lands to be acquired under the intended Act, and to provide that in deter-mining the amount of such compensation regard shall be had to the increase in value of other lands of the person claiming compensation resulting from or caused by the construction of the works proposed to be authorized, and the exercise of the other provisions of the intended Act, and to other circumstances to be mentioned or referred to in such Act, and that any buildings erected, alterations made, or interest created after the date hereof, or such other date as may be mentioned in the intended Act, shall not be taken into consideration

III., cap. lxxxvi., into execution (hereinafter called

"the Harbour Undertaking ") together with all or some of the works, lands, waters, property, powers, rights, privileges and authorities vested in, held by or belonging to or exercisable by the said Commissioners (hereinafter called "the Commissioners ")

8. To authorize the Council and the Commissioners to enter into and carry into effect an agreement or agreements with relation to all or any of the purposes of the Bill and to confirm and sanction any such agreement that
