East Woodhay, Ashmansworth, Newtown, and Crux Easton, and the portions of the parishes of Kingsclere, Ecchinswell, and Sydmonton lying to the north of a line drawn along the northern fences of Freemantle Park Down, Cannon Heath Down, Watership Down, Sydmonton Down, and Hare Warren Down respectively.

# ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 9th DECEMBER, 1912.)

SHEEP SCAB (CARNARVONSHIRE SPECIAL DIPPING AREA) ORDER OF 1912.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

### Modification of Order.

1. The Sheep-Scab (Carnarvonshire Special Dipping Areas) Order of 1910 (hereinafter referred to as the principal Order) is modified in manner hereinafter appearing.

Restrictions on Movement of Sheep out of Area.

- 2. (1.) The restrictions on movement of sheep imposed by Article 2 of the principal Order shall apply only between the thirty-first day of May and the first day of December in each year.
- (2.) For paragraph (2.) of Article 6 of the principal Order the following paragraph shall be substituted:—
  - "(2.) If a movement licence is available for any day between the thirty-first day of May and the first day of September, or if it relates to sheep which have within seven days before the licence is granted been moved into the Special Dipping Area with a market licence, the sheep to be moved must have been dipped once within forty-two days before the licence is granted."

## Commencement.

3. This Order shall come into operation on the twelfth day of December, nineteen hundred and twelve.

#### Short Title.

4. This Order may be cited as the SHEEP SOAB (CARNARVONSHIRE SPECIAL DIPPING AREA) ORDER OF 1912, and shall be read with the principal Order.
